COMBINED CITY & SCHOOL ELECTION NOVEMBER 2, 2021**

PUBLIC NOTICE IS HEREBY GIVEN that the **Combined City & School Election** in the County of Delaware, State of Iowa, will be held on **Tuesday, November 2, 2021**. Polls will be open from 7:00 a.m. until 8:00 p.m. Voters must vote in their precinct of residence. Please read this notice carefully to determine your correct location. The new law establishing this combined election requires General Election polling places to be used whenever possible – which will be the case in Delaware County. If you are unsure of your voting precinct for this election, please contact the Delaware County Auditor & Commissioner of Elections at (563)-927-4701 or by e-mail auditor@co.delaware.ia.us. Pre-registered voters are now required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered (such as voters registering on Election Day, and voters changing precincts), must also provide proof of residence. The following documents can be used as proof of residency if they contain your name and current address, and are current within 45 days of this Election: Residential lease, utility bill, bank statement, paycheck, government check or other government document, or a property tax statement (current within 45 days of final payment due date). Voters who are unable to provide an approved form of identification (or prove residency if required), may have their identities attested to by another registered voter in the precinct, or have the right to cast a provisional ballot. Attesters must also provide an approved form of identification. Pre-Election Day voter registration for this election closed on Monday, October 18, 2021 at 5:00 p.m. It was highly recommended that those persons wishing to vote in this election should have pre-registered on or before the October 18th deadline. However, eligible persons have the right to register to vote and cast a ballot on Election Day if they are able to provide proof of both their identity and residency at the polls. Please bring a valid and current photo ID that has an expiration date. If the address on your ID is not current, you will need to prove residency.

The last day to request an absentee ballot **by mail** was Monday, October 18, 2021 at 5:00 p.m. However, **In-person** absentee voting is available at the Delaware County Auditor's Office thru 5:00 p.m. on Monday, November 1, 2021.

All polling places designated for use in this election are accessible to persons with disabilities. Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. Voting equipment to be used in this election will be tested and certified on Friday, October 29, 2021 at 9:00 a.m. in the Jail Basement located within the courthouse at 301 E Main Street, Manchester, Iowa. The public is invited to attend. Regarding the questions on the ballots for the Maquoketa Valley Community School District, the Monticello Community School District and the Western Dubuque County Community School District:

If a majority of eligible electors voting on the question fail to approve this Revenue Purpose Statement, then upon expiration of the current Revenue Purpose Statement, revenues received by the School District from the Secure an Advanced Vision for Education fund shall be expended in the following order:

The payment of bonds for which SAVE Revenue has been pledged;

Reduction of bond levies under Iowa Code Sections 298.18 and 298.18A and all other debt levies;

Reduction of the regular and voter-approved physical plant and equipment levy under Iowa Code Section 298.2;

Reduction of the public educational and recreational levy under Iowa Code Section 300.2;

For any authorized infrastructure purpose of the school district as defined in Iowa Code Section 423F.3(6); and
 For the payment of principal and interest on bonds issued under Iowa Code Section 423E.5 and 423F.4.

PUBLIC MEASURE E

Summary: To adopt a Revenue Purpose Statement specifying the use of revenues the Maquoketa Valley Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund.

In the Maquoketa Valley Community School District, the following Revenue Purpose Statement which specifies the use of revenues the Maquoketa Valley Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund shall be adopted.

To provide funds to acquire or install information technology infrastructure (including improving buildings or sites for the purpose of accessing broadband digital telecommunications) and school safety and security infrastructure.

To provide funds to build and furnish a new school building or buildings; to build and furnish addition(s) to school buildings in the District; to remodel, reconstruct, repair, expand, and improve the school buildings in the District; to purchase and improve grounds; for demolition work; to furnish and equip district facilities.

To provide funds for the purchase, lease or lease-purchase of buildings, equipment (including transportation and recreation equipment), or technology and to repair transportation equipment for transporting students as authorized by law, to implement energy conservation measures, sharing or rental of facilities including a joint infrastructure project for the purposes of offering classes under district-to-community college programs as authorized in Iowa Code Section 423F.3(3)(c), procuring or acquisition of libraries, or opening roads to schoolhouses or buildings.

To provide funds to purchase land as part of start-up costs for new student construction program or if the sale of the previous student construction was insufficient to purchase land, and to purchase construction materials and supplies for a student-constructed building or shed intended to be retained by and used by the District.

To provide funds to make payments to a municipality or other entity as required under Iowa Code Section 403.19(2).

To provide funds for demolition, cleanup, and other costs if such costs are necessitated by, and incurred within two years of, a disaster.

To provide funds to establish and maintain public recreation places and playgrounds; provide for supervision and instruction for recreational activities; or for community education purposes.

To provide funds for the payment of principal and interest or retirement of general obligation bonds issued for school infrastructure purposes, energy improvement loans, loan agreements authorized by Iowa Code Section 297.36, sales, service and use tax revenue bonds issued under Iowa Code Section 423E.5 or Iowa Code Section 423F.4.

To provide funds for property tax relief;

and To provide funds for other authorized expenditures and purposes as now or hereafter permitted by law and designated by the Maquoketa Valley Community School District.

It being understood that if this proposition should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the voters to expend receipts from the Secure an Advanced Vision for Education Fund.

If approved, this Revenue Purpose Statement shall remain in effect until replaced or amended by the Maquoketa Valley Community School District.

EDGEWOOD-COLESBURG COMMUNITY SCHOOL DISTRICT

PUBLIC MEASURE F

Shall the Board of Directors of the Edgewood-Colesburg Community School District in the Counties of Clayton and Delaware, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$12,050,000 to provide funds to remodel, repair, improve, and equip the Elementary School facility, including HVAC improvements; to build, furnish, and equip additions to the Junior/Senior High School facility, including a new competition gym and new space for career and technical education, with related remodeling and improvements, safety and security upgrades, and site improvements, including relocation of the main entrance and drop-off and pick-up areas?

PUBLIC MEASURE G

Shall the Board of Directors of the Edgewood-Colesburg Community School District in the Counties of Clayton and Delaware, State of Iowa, be authorized to levy annually a tax exceeding Two Dollars and Seventy Cents (\$2.70) per Thousand Dollars (\$1,000), but not exceeding Four Dollars and Five Cents (\$4.05) per Thousand Dollars (\$1,000) of the assessed value of the taxable property within said school corporation to pay the principal of and interest on bonded indebtedness of said school corporation, it being understood that the approval of this proposition shall not limit the source of payment of the bonds and interest, but shall only operate to restrict the amount of bonds which may be issued?

Summary: To adopt a revenue purpose statement to authorize the expenditure of revenue from State of Iowa Secure an Advanced Vision for Education Fund received by the Monticello Community School District.

Revenue Purpose Statement:

Revenue received by the Monticello Community School District from the State of Iowa Secure an Advanced Vision for Education Fund may be spent for any one or more of the following purposes:

To provide funds for property tax relief.

To provide funds to acquire or install information technology infrastructure (including improving buildings or sites for the purpose of accessing broadband digital telecommunications) and school safety and security infrastructure.

To provide funds to build and furnish a new school building or buildings; to build and furnish addition(s) to school buildings in the District; to remodel, reconstruct, repair, expand, and improve the school buildings in the District; to purchase and improve grounds; for demolition work; and to furnish and equip District facilities.

To provide funds for the purchase, lease or lease-purchase of buildings, equipment (including transportation and recreation equipment), or technology and to repair transportation equipment for transporting students as authorized by law, to implement energy conservation measures, sharing or rental of facilities including a joint infrastructure project for the purposes of offering classes under District-to-community college as authorized in Iowa Code Section 423F.3(3)(c), procuring or acquisition of libraries or opening roads to schoolhouses or buildings.

To provide funds to purchase land as part of start-up costs for new student construction program or if the sale of the previous student construction was insufficient to purchase land, and to purchase construction materials and supplies for a student-constructed building or shed intended to be retained by and used by the District.

To provide funds to make payments to a municipality or other entity as required under Iowa Code section 403.19(2).

To provide funds for demolition, cleanup, and other costs if such costs are necessitated by, and incurred within two years of, a disaster.

To provide funds to establish and maintain public recreation places and playgrounds; provide for supervision and instruction for recreational activities or for community education purposes.
